Applications are invited for the following posts in various projects under Multi Disciplinary Research Unit (MRU), Silchar Medical College & Hospital, Silchar, Assam on purely temporary and contractual basis. The posts are not under Govt. of Assam. Candidate cannot lay claim to any permanent employment/ appointment on the basis of their being appointed to any of these posts which are purely temporary and contractual. The appointment may be terminated at any point of time without assigning any reason or without any notice.

- Posts: 1. Junior Research Fellow (JRF) – 02 Post @ Rs. 31000+ HRA (as admissible)**
2. Lab Technician for MRU – 01 Post @ Rs 20,000 + HRA (as admissible)

1. Eligibility criteria for Junior Research Fellow (JRF) for the project entitled “Community engagement for climate action- An intervention model to address health effects due to climate change in Assam state of India based on local vulnerabilities”

- Masters degree in Ecology and Environmental Science/ Social work / Geography from recognized University with at least 1 year of work experience in the respective field. However, preference will be given to candidate having an experience of field work survey, data collection and analysis.
- The nature of duties comprises to collect field / village level information by working in remote villages and tough mountainous conditions of Dima Hasao and Karbi Anglong and other district of Barak Valley, Assam.
- Candidates should have a good communication skill along with proficiency in English, Bengali, Hindi & Assamese.
- Ability to work independently and to collaborate across different sectors relating to climate change.
- Expertise in computer operation (certificate to be enclosed) with data entry related works and analysis using software.
- Basic knowledge of software and hardware and able to attend trouble shooting of computer, printer and network connectivity.

2. Eligibility criteria for Lab Technician for MRU

- HSSLC pass in science /equivalent and two years Diploma/Graduate/ Masters in medical laboratory technician from a recognized board / University.
- Basic knowledge of software and Hardware and able to attend trouble shooting of computer, printer and network connectivity.
- Preference will be given to candidates with one year working experience in health research projects in Govt. institution or in ICMR/DHR/IDSP/CSIR/DBT or any other project/Medical college.
- B.Sc degree will be treated as three years experiences.

Terms & Conditions

1. Terms: Posts are purely temporary. Appointments will be initially for a period of 89 days and may be extended further based on the tenure of the project & performance of the staff. However, the appointment can be terminated at any time even before the end of the contract period due to any reason. In case of such premature termination, one month's notice or one month's salary in lieu of the same will be provided. The same will not hold true in case of premature termination due to performance related issues. Candidate can leave the job prematurely giving one month's notice or one month's salary in lieu of the same.

2. Application and Selection procedure: It will be a **Walk in Interview**. The candidates need to appear in front of the interview board along with the standard format of application, Biodata, recent self-signed passport photograph & original certificates. 
3. Date & time of interview: 09.01.2024 at 11:00 AM ; Reporting Time: 9:30 AM – 10:30 AM
