1. KEY TERMS

Following words and terms used in this document shall, unless the context requires otherwise, have the following meaning:

- a. "Tender" or "Bid" means the formal offer to supply items.
- b. "SMCH" means Silchar Medical College & Hospital
- c. "EMD" means Earnest Money Deposit
- d. 'Applicant' or 'Tenderer' or 'Bidder' means the person submitting the Tender pursuant to the Notice Inviting Tender.
- e. "Committee" means Tender and Purchase Committee
- f. "Chairman" is the Chairman of the Tender & Purchase Committee, SMCH, Silchar
- g. "Term" means the term commencing from the Commencement Date, until the termination of the rate contract awarded to the successful bidder to Disposal/Lifting of Various Waste Materials and Scrap Materials.

2. TERMS & CONDITIONS

a. Eligibility and Qualifications

1. Any registered Manufacturer/Authorized dealer/Distributor/ Firm / Vendor having **valid trade license** (Copy to be attached with annexure-1)
2. Proven ability and experience of providing similar work to Govt., Semi-Govt. Organisation or PSU (proof to be attached with annexure-1)
3. **GST Registration** and proof of filing GST Return for any month of the year 2022. Proof of return filed before 2022 shall not be accepted (proof to be attached with annexure-1)
4. **PAN** of the Proprietor/ Manufacturer / Authorized dealer / Distributor / Vendor (copy to be attached with annexure-1)
5. **Not blacklisted** by any Government Departments for any type of contract, be it Disposal/Lifting of Various Waste Materials and Scrap Materials or others.
6. The bidder will have to submit an undertaking as per annexure II in stamp paper of Rs 100/-.

b. Mandatory Requirements on the part of the bidder

- ii. Declaration on non-judicial stamp paper of ₹50/- duly attested by Notary Public to the effect that the Applicant is not barred or black-listed on any Government Department or public sector Undertaking- Original copy to be attached. Submission of photocopy will disqualify the tender.
- iii. Detailed financial statement of bank account showing balance on the last day of each month of January 2023, February 2023, December 2022, November 2022, October 2022 and September 2022 to be attached failing which the submitted tender will be summarily rejected.
- iv. A self-certified Certificate of furnishing correct information is to be submitted by the bidder to the effect that correct information has been furnished in the Tender and the Applicant shall be solely responsible for furnishing misleading, wrong or false information. Furnishing of misleading, wrong or false information if detected by the Committee will lead to the rejection of the submitted tender document.
- v. Price bid duly filled up as per annexure III.

c. Earnest Money Deposit

Tenderer shall furnish along with their tender an Earnest Money Deposit of ₹ 10,000/- (ten Thousands only) in the form of Demand Draft in favour of **“Hospital Management Society, Silchar Medical College & Hospital, Silchar”** payable at Silchar. Earnest money in any other form of cash/Cheque/fixed deposit shall not be accepted.

Tender not accompanied by the EMD shall be summarily rejected on the day of opening the tender document itself

Earnest Money Deposit of unsuccessful bidders shall be returned on written application mentioning the demand draft number without interest after the finalization of the tender. Bidders are advised to keep photocopy of the EMD instrument with them.

d. Price Schedule and Payment Terms

Tenderers should quote rate of each Item without fail. The Rates should be quoted as per specification excluding of all types of current taxation. Tax levied to be deposited by the successful bidder and one copy of challan to be submitted to the SMCH authority. Payment should be cleared before disposal or lifting of scrap material from the SMCH premises, by online payment to SMCH authority.

Disposal/Lifting Period

The Items should be Disposed/Lifted within 7 days (including holidays) from the date of issue of contract order. The Disposal/Lifting shall be on the risk and responsibility of the firm. No lifting/carrying charges or any other charges whatsoever extra shall be paid. Submission of proof of Disposal/Lifting shall be mandatory for clearing the payment related matters.

Successful bidder should maintain a logbook mentioning the amount of scrap lifted or disposed counter signed by the In-charge Scrap Committee of SMCH and pay the amount as per logbook in online transaction (through SMCH POS/SMCH State Bank Of India RTGS/NEFT) in favour of Hospital Management Society, SMCH.


e. Penalty Clause

- i. **For delays:-** If the successful bidder fails to Dispose/Lift the Items as per contract order within the time period specified in the contract, the SMCH authority shall deduct from contract price/EMD a sum equivalent to 0.5% of the price of delayed items for each week of delay or part thereof until actual delivery up to a maximum of 10(ten) percent. Once the maximum is reached, the SMCH authority may consider termination of the contract.
- ii. **Termination of default:-** The purchaser may, without prejudice to any other remedy or breach of contract, by written notice of default sent to the successful bidder, terminate the contract in whole or part if the successful bidder fails to lift/dispose any or all items ordered to him within the time period specified in the contract, or if the successful bidder fails to perform other obligation under the contract. In the event of the termination of the contract by **SMC & H, Silchar, Cachar** in whole or in part, the SMC & H, Silchar, Cachar may procure, upon such terms and in such manner as it deems appropriate the lifting/disposal items and the successful bidder shall be liable to pay for any excess cost for such lifting/disposal. However, the successful bidder shall continue performance of the contract to the extent not terminated.
- iii. **Force majeure:-** The successful bidder shall not be liable for (i) and (ii) above, if its delay in performance or other failure to perform its obligations under the contract is the result of an event of force majeure (Means an event beyond the control of the successful bidder and not involving the successful bidder's fault or negligence and not foreseeable). Such events may include, but or not restricted to, acts of God, severe natural calamities, wars or revolution, fires, floods, epidemics, quarantine restrictions and freight embargo. The successful bidder shall promptly notify the SMCH authority of such conditions and

the causes.

- f. Superintendent, Silchar Medical College and Hospital reserves the right to accept or reject any tender or the whole tendering process and reject any or all tenders at any time prior to award of the contract, without thereby incurring any liability to the affected Bidders or any obligations to inform the affected Bidders of the grounds.

3. RESOLUTION OF DISPUTES

In case of a dispute or difference arising between successful bidder and SMCH authority relating to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the sole Arbitrator duly appointed by The "Hospital Management Society, Silchar Medical College & Hospital, Silchar". The award of the arbitrator shall be binding to the parties concerned.

4. SUBMISSION OF TENDER DOCUMENT

Bidder should use two envelopes one for technical bid and another for financial bid. These two envelopes should be inserted in a big envelope mentioning the tender name and particulars of the bidder. Envelope should be dropped in the box of the Office of the Principal Cum Chief Superintendent, Silchar Medical College & Hospital.

The full name and address, phone number and e-Mail id of the tenderer submitting the tender shall be written on the envelope. The Tenders must be dropped in the tender box at the Office of the Principal cum Chief Superintendent, Silchar Medical College & Hospital, Silchar, Assam-788014. Tender submission through post will not be accepted.

5. OPENING OF TENDERS

6. Following procedure shall be adopted for the opening of Tenders:
7. The envelope containing the tender document with all enclosures will be opened on the date and time as scheduled. After opening the bidding documents, the numbers of pages present in the technical envelope will be counted in presence of all the bidders. However the evaluation of the technical documents will be conducted afterwards in presence of all the members of the Tender and Purchase committee only.

8. SELECTION OF SUCCESSFUL BIDDER

- a. Highest Price will be taken in to account while selecting the successful bidder.
- b. The committee, if desires may or may not take suggestion from competent authority in deciding the successful bidder but the suggestion given by those authorities shall

not be binding on the committee. The decision taken by the committee in selecting the successful bidder will be final and the same will be recommended to the Superintendent for award of contract. However, the recommendation made by the committee shall not be binding on the Superintendent, SMCH. The superintendent may accept or reject the recommendation made by the committee and take steps as he deems fit and proper as per rules.

- c. The committee reserves the right to decide whether to take any suggestion from any other competent authority in the entire bidding process.

9. WARNING

Canvassing in any form either verbal, written, digital, telephonic or third party approach etc. to chairman, member secretary or any of the members of the Tender & Purchase Committee will be a disqualification. The committee shall not entertain any recommendation letter or forwarding related to this tender or personal letter of any Govt./Non-Govt. Authority/Individual in any stage of the tendering process till award of the final contract. In case, a bidder is found to be submitting such recommendations, either directly to the committee or through the College or Hospital Authority of Silchar Medical College, Silchar or any other authority at any stage of the tendering process, the committee will summarily reject that tender document.

10. List of items to be scraped are mentioned in the annexure IV.

11. Weighing of scrap material:

Successful bidder should install a manual weigh scale near the scrap store site of SMCH and the weighing scale should be capable of weighing of minimum 150 kg.

Scrap material which can't be weighed manually onsite will be weighed from the nearest weigh bridge from SMCH, Silchar and expenditure related to weighing will be borne by the successful bidder.


