The firm/Suppliers/Distributors have to abide by following terms and conditions:-

- 1. IT return for last three Assessment Year 2019-2020,2018-2019,2017-2018.
- 2. Valid current trade license as per tender articles.
- 3. Valid GST Registration Certificate.
- 4. PAN card.
- 5. Bank Account Number/Branch name/ IFSC.
- 6. The Firm/Suppliers/Distributors should complete the above mentioned supply works within 03 days from the date of issue of work order.

7. OTHER CONDITIONS

A. Item Details & Quantity

The items & the quantity mentioned is only the tentative requirement and may increase or decrease as per the decision of Tender Inviting Authority. The rates quoted should not vary with the quantum of the order or the destination.

B. Firm Rates

Firm Rates (inclusive of GST, packing, forwarding, handling, transportation, insurance, Charges and any incidental charges) should be quoted for each of the required items. Tender for supply of equipments with conditional/variable rates shall not be accepted. Handling, clearing, transport charges etc., will not be paid separately. The delivery should be made as stipulated in the purchase order placed with the successful bidders. The rates quoted and accepted will be binding on the Bidder for the stipulated period and any increase in the price will not be entertained till completion of the tender period.

C. Controlled Price/MRP

The price quoted by the bidders shall not, in any case exceed the controlled price, if any, fixed by the Government and the Maximum Retail Price (MRP). During the period of contract with the successful bidder, if the price of any item is reduced due to any reason including any Law or Act of the Central/State Government, the bidder shall be statutorily bound to intimate the reduced rates immediately to the Tender Inviting Authority and shall charge the reduced rates. The Tender Inviting Authority is empowered to unilaterally effect such reduction as is necessary in rates, in case the bidder fails to notify or fail to agree to such reduction in rates.

8. Financial bid Annexure-I, Declaration Annexure-II & Undertaking of Bidder Annexure III

- 9. The undersigned is not bound to accept the lowest rate & reserve the right to cancel/reject any or all quotation(s) without assigning reason thereof.
- 10. In case there is delay in delivery beyond the stipulated period as mentioned in the purchase order, there shall be reduction in price @ 0.5% of the value of delayed goods per week of delay or part thereof subject to a maximum of 10% of the total order value.
- 11. Over written rates will not be accepted.
- 12. The rates approved will not be enhanced at any cost during the tenure of the contract period.

- 13. No advance payment will be made in any case.
- 14. GST and Income Tax will be deducted at source as per norms of State/ Central Government.
- 15. Payment in respect of bills against the services provided by the bidder will be made through PFMS system only on submission of bill in triplicate after satisfactory supply/receipt of items in full and good condition.

16. TENDER ACCEPTANCE

The acceptance of the tenders will be communicated to the successful bidders in writing.
