- 13. SMCH reserves the right to have selection of item listed in the tender from any company/manufacturer depending upon the design, requirement of item by end user and technical specification of the item. No claim from any vendor shall be entertained by SMCH.

- 15. Supplier shall submit the bills after successful delivery, installation, Training and commissioning of the machine and submission of invoice along with warranty card.

The software shall have superlative range of flexible functions such as, late-in Early-out policy overtime policy absentee policy, Multiple Holidays, manual entry and correction entry. Exit Events and Attendance summary as a part of Time- Attendance software. It should have provision to create multiple branches department, search designations grades and categories.

- 28. While all efforts have been made to avoid errors in the drafting of the tender documents. The bidder is advised to check the same carefully. No Claim on account of any error detected in the tender documents shall be entertained.
- 29. The tender (quoted rates) shall be valid for acceptance for period of 90 days from the date of opening and further extendable by a fortnight at discretion of SMCH authority.
- 30. If two or more firms quoted same, contract will be awarded to the firm who have maximum previous experience of providing similar service.
- 33. Training:

On Site training to Technicians/ staff is to be provided by Agents (if they have the requisite know- how) for operation and maintenance of the equipment to the satisfaction of the user department.

- 34. The bidder shall provide backup services of trained Technical Personnel on 24 hours basis for emergency requirement. Complaints should be attended properly, maximum within 8 hours. The service should be provided directly by Tenderer /Indian Agent. Undertaking by the Suppliers that the spares for the equipments shall be available for at least 5 years for the date of supply.
- 35. CMC
