- 1. The interested Govt. Agencies/Supplier/Manufacturer may submit their sealed quotations along with samples so as to reach the office of the Superintendent, SMCH, Silchar on or before 4-2-2022 at 1:00 PML
- 2. The bidder must mention the name of the firm and its contract numbers on sealed cover superscribing 'Tender for uniform'. An Earnest Money Deposit of Rs. 20,000.00 (Rupees Twenty Thousand) only in the form of Demand Draft drawn on any scheduled commercial Bank in favour of Hospital Management Society, Silchar Medical College & Hospital, Silchar payable at Silchar must accompany the bids. Quotations received after closing date and time and without EMD or EMD in a form other than Demand Draft will not be considered at all.
- 3. The details of terms condition for submitting of bid are as under:-
- a. The sample will be selected by duly constituted Tender Evaluation Committee of this office. One or more items of the same firm may be selected by the Committee and accordingly. Order shall be placed to the firm for one or more items. In other words, different firm may be awarded contract for different articles of uniform depending on quality and rates. The decision of the committee will be final and binding on all bidders.
- b. Bidders are required to furnish their complete address and telephonic numbers along with PAN/TAN, GST Registration certificate and required EMD in Technical bid etc. Income tax returns for FY 2018 2019 and 2019-2020.
- c. A firm blacklisted by any Govt./State Government office will not be eligible to participate in this tender. In case any such firm obtain contract by hiding this fact and it comes to this notice of this office later, contract will be terminated immediately and security deposit shall be forfeited. The items of uniform already supplied will also be confiscated. Any firm under investigation by government agencies should give a disclosure stating so.
- d. The bid document must be typed with font size 12(Calibri/Times New Roman). Incomplete or conditional tenders will not be entertained. All the Annexures should be filled up and submitted.
- e. The successful bidder will have to sign a rate contract agreement with the undersigned which will be effective effective for 23(twenty three) months after acceptance. Any request for increase in the approved rates will not be entertained for any reason for the contract period for any reason and the items required to be supplied by the contractor should strictly be in accordance with the sample approved.

- Termination for Default The Buyer may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Supplier, terminate the Contract in whole or part:
- if the Supplier fails to deliver any or all of the Goods within the period(s) specified in the i. Contract, or within any extension thereof granted by the Purchaser
- if the Supplier fails to perform any other obligations(s) under the Contract. ii.
- if the Supplier, in the judgment of the Purchaser has engaged in corrupt or fraudulent iii. practices in competing for or in executing the Contract.
- For the purpose of this Clause: "Corrupt practice" means the offering, giving, receiving or iv. soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution. "Fraudulent practice" means a misrepresentation of facts in order to influence the procurement process or execution of the contract to the detriment of the Purchaser, and includes collusive practice among bidders (prior to or after Bid submission) designed to establish Bid prices at artificial non-competitive levels and to deprive the purchaser of the benefits of free and open competition.
  - In the event the Buyer terminates the Contract in whole or in part, the Buyer may procure, ٧. upon such terms and in such manner as it deems appropriate, Goods or Services similar to those undelivered, and the Supplier shall be liable to the Buyer for any excess costs for such similar Goods or Services. However, the Supplier shall continue the performance of the Contract to the extent not terminated.

- n. Successful bidder will have to attend the office for taking individual measurement maintaining a register under signature of the office staff. The above mentioned itemswill be finished items as per individual measurement which have to be obtained from the office placing order, cloth and other material shall be as per approved sample.
- o. Any material is not as per the sample/measurement will be rejected and the replacement of the same shall be made by the bidder without claiming any extra cost.
- p. Supply order will be placed time to time according to requirement. The items are to be supplied at the site.
- q. The suppliers will have to supply the complete sets within 3(three) weeks from the date of issue of the supply order.
- r. Payments against bill/invoice shall be released only after supply/inspection and observance of satisfactory supply of the uniforms.
- No advance payment will be made any case.
- t. The hospital authority reserve to impose any other condition for regulating the contract in public interest.
- u. In case successful bidder is found in breach of any condition/tender at any stage, legal action as per rules/laws shall be initiated against the agency concerned. In that case EMD/Performance security shall be forfeited after giving proper opportunity through show cause notice.
- v. All disputes are subject to the jurisdiction of courts in Silchar and agreement will be governed by and be constructed in accordance with the laws of India.
- w. Interested firms/Parties will have to submit unconditional acceptances to the above terms and conditions at the time of submission of the quotation on the letter head of the firm.
- x. The bidders who does not fulfil any of the above conditions and incomplete tenders are liable to be summarily rejected at the risk and cost of the bidder only and any further correspondence in this regard will not be entertained.
